What is the overall deductible ?	\$3,250/person or \$6,500/family for In- Network Providers . \$3,250/person or \$6,500/family for Non- Network Providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive Care for In- Network Providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	\$6,500/person or \$13,000/family for In- Network Providers . \$9,250/person or \$18,500/family for Non- Network Providers .	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Services deemed not medically necessary by Medical Management and/or Anthem. Premiums , balance-billing charges, health care this plan doesn't cover, and Non- Network Transplants.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

What is not included in the out-of-pocket limit? (Continued)	Coinsurance for certain specialty prescription drugs considered non-essential health benefits under the plan. The coinsurance for these drugs (though manufacturer copay assistance programs may support some fills at no remaining cost to you) will not apply toward satisfying the ACA out-of-pocket maximum. Will you pay less if you use a network provider?	Yes, BlueCard PPO. See www.anthem.com or call (844) 879-5710 for a list of network providers .	This plan uses a provider network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing).
